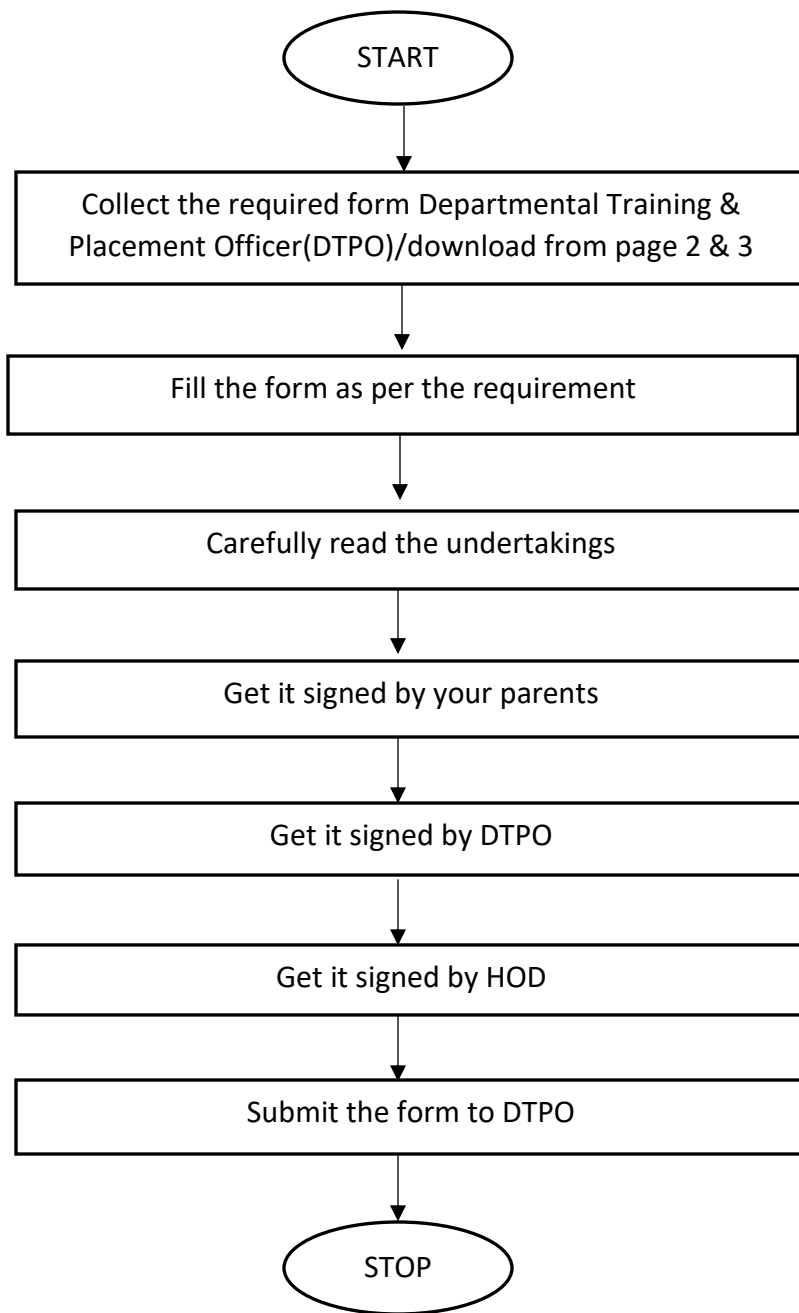

- g) I understand that if my attendance in Pre-Placement Training is Less Than 75%, I will be disqualified from participating in all campus hiring event.
- h) I shall appear for placement / internship drives if my candidature fulfills the eligibility criteria as per the recruiter's guidelines and my name is listed as eligible student by T&P. Any absence will lead to disqualification from all hiring events organized by T&P and I shall also be denied Letter of Recommendation for Internships / Off-Campus hiring.
- i) I shall maintain sanctity of examination during placement drives (written / oral / computer based examination or any other form of assessment). In case I am found to indulge in any act of malpractice or misbehaviour, suitable disciplinary action (including debarring from all placement drives or rustication etc) may be initiated against me.
